The deadline to do so is Friday at Noon. Vendors, who rent a space on a weekly basis, **must pay in advance to guarantee** a reserved space. If you do not pay in advance, the sites may not be available as they are assigned on a first-come, first- served basis. Booth fees are non-refundable.
